Nourish Colorado is a statewide nonprofit organization committed to ensuring nutritious food access for all Coloradans by pursuing systemic changes through state and federal policy advocacy, managing innovative programs, and developing community partnerships and grassroots networks to employ in multiple-win strategies that rebalance the food system and create nutritious food environments.

**Form 990, Part III, Line 4a - First Accomplishment**

Through our Healthy Food Incentives work, we utilize local and state funding to draw additional federal funding into Colorado so participants of government-funded food programs have increased access to healthy, Colorado-grown products. Our largest nutritious food incentive program is the Double Up Food Bucks program which enables participants in the Supplemental Nutrition Assistance Program (SNAP) to use incentives to purchase Colorado-grown produce at more than 100 farmers markets, some grocery stores, and innovative local retailers (including Community Supported Agriculture, Food Co-Operatives, Corner Stores, and Urban Agriculture Marketplaces) across the state. SNAP Families can receive vouchers for up to \$20 per day toward the purchase of Colorado grown fruits and vegetables. In 2020, over \$480,000 in Double Up Incentives were redeemed and an estimated 400 farmers participated in the program. This program helps SNAP customers with increased access to healthy food, gives producers access to new and/or expanded markets for their products, and contributes to the local economy. Importantly, 84% of customers

participating in the program report they are eating more fruits and vegetables. The program is enhanced through strong partnerships with Cooking Matters which offers on-site nutrition education at farmers markets, Colorado Farmers Market Association, Boulder County Public Health, and The Colorado Department of Humans Services which also facilitated a post card marketing campaign for the program in Denver. Nourish utilizes Community Food Advocates to create a grassroots and sustainable incentive program by working with SNAP participants as key ambassadors and decision makers in program outreach and planning, with a goal of increasing life-long fruit and vegetable consumption by SNAP participants. Also included in our Healthy Incentives program was the Colorado Nutrition Incentive program (CNIP) which distributed almost \$570,000 to farmers throughout the state to purchase Community Supported Agriculture (CSA) shares to be distributed to participants in the Women, Infants, and Children (WIC) program and older adults in the Older Americans Act Congregate Nutrition program. CNIP distributed to nearly 1,200 households in 25 counties through 10 WIC programs and four Older Adult programs. Program evaluation demonstrated that 91% of WIC participants and 84% of older adult participants reported an increase in food security through the program.

Form 990, Part III, Line 4b - Second Accomplishment

Local Procurement Colorado, LoProCo, is designed to grow and strengthen local and regional food systems by increasing the purchasing power of institutions that procure and prepare food, while also connecting those institutions to local and regional producers. The primary institutional participants at this point are K-12 school districts. The program is designed to increase local purchasing of healthier products to strengthen

the food system while also providing access to healthier within these institutions. Through culinary workshops which teach the fundamentals of scratch cooking, knife skills, and safe food handling, Nourish staff, along with a dedicated team of on-site chef consultants, partner with institutions to create sustainable action plans to improve meals served and foster relationships between local producers and institutions serving the public. In addition, in 2020 Nourish worked with the Colorado Department of Public Health and Environment to create a culinary training video for Early Care and Education food service staff who prepare meals for child and adult care food service sites. Also, as part of our Healthy Food in Institutions efforts, Nourish, working with multiple partners, amended and updated HB19-1132 via HB20-1300, the Colorado School Food Purchasing Program, a three-year pilot program providing a \$.05 cent per lunch reimbursement for participating schools to purchase Colorado grown, raised, or minimally processed products. The program also provides technical assistance to producers, food system intermediaries, and school nutrition program staff. Unfortunately, due to the pandemic's effect on the state budget, the program's funding was eliminated, and the program was put on hold.

Through our Healthy Food Policy work, Nourish leads and supports state and federal policy efforts that leverage resources and allocates them in ways that increase equitable access to nutritious food for all Coloradans. Nourish plays a lead role in mobilizing input from around the state and presenting a unified voice from local food coalitions and other partners on a wide range of legislative and regulatory issues. Due to the pandemic, our policy efforts shifted from legislative work to fundraising for moving

money to smaller and mid-size farmers who directly serve their communities and could provide nutritious food at a time when the demand for food was increasing dramatically. Along with others, we formed the Colorado Farm and Food System Response Team that moved \$1.9M to Colorado producers, assisting local economies, producers, and consumers.

Initial CEO compensation was set in 2016 by the Executive Committee of the Board of Directors with the use of surveys from well-established sources, including the Employers Council (EC) survey as a primary local source, and CEO compensation is reviewed annually by the Executive Committee. During the annual budget process, management adjusts salaries based upon annual salary survey data from the EC, the Bureau of Labor Statistics and other sources. The President and CEO approves the compensation for VPS and key employees. The Finance Committee of the Board of Directors reviews and approves the adjustments to the overall personnel budget during the annual
