#### *About Nourish*

Nourish Colorado ([www.nourishcolorado.org](http://www.nourishcolorado.org)) strengthens connections with and between farms, ranches, and communities so that all Coloradans have equitable access to fresh, nutritious foods. We achieve our mission by engaging in policy advocacy for systemic change, managing innovative programs, and developing community partnerships and grassroots networks to rebalance the food system and create healthy food environments.

#### *Board Description*

There are 5 to 15 elected board members, per the by-laws. The term of service is three years. Board members may serve up to two terms (six years) consecutively. The Board currently meets on the 2nd Thursday of each month at 4pm via Zoom. The Executive Committee (which is currently fully seated) and other ad-hoc committees meet other times as needed. We hold many values sacred in our work, a primary one being building an organization that at its core is focused on equity. We work to establish practices and policies that advance multiracial and multicultural shared power in the food systems space specifically. We aim to do this throughout our organization – from who and how we hire, who sits on our Board of Directors as well as community advisory board, to where we bank, with whom we advocate, how we write grants and how close we hold our partnerships. We are currently seeking a minimum of three new members for the Board of Directors. While we always appreciate individuals who have relevant and direct experience with our areas of work such as farming, nutrition security, and school food, we are specifically seeking three individuals that will each bring one of the following areas of skill and knowledge to the Board:

*Legal:* Nourish is a growing organization that is now going fully remote and manages several complex federal and state contracts. We have found repeated and consistent needs for legal guidance on HR policies, vendor contracts, and more. Enhancing our Board with in-house legal expertise will strengthen our ability to be nimble and responsible in our operations.

*Human Resources:* We have been fortunate in the past to have Board members (who have termed off) with extensive HR experience. Having this guidance in-house as positions are changed and we experience growing pains has been invaluable to our Director of Office & Human Resources.

*Accounting:* See note about complex grants and contracts above! We have long been seeking an accountant to act as Treasurer of the Board and to support our Senior Director of Budget and Operations in presenting our monthly financials to the Board and to help guide the development of the annual budget so that it adheres to both our values and our financial reality. In addition, it would be a plus if this role also has experience with government contracts and grants since this encompasses a high percentage of the organization's finances.
